Admissions information

Admissions policy statement

The LSA is committed to ensuring that applicants are recruited, selected and assessed solely on their relevant merits and abilities and in accordance with the LSA entry criteria. The LSA supports equal opportunities and therefore no applicant will be treated less favourably on the grounds of disability, religion, race, colour, nationality, ethnic or national origins, sexual orientation, gender, marital status or political beliefs.

Admission requirements

Applicants should have a 2.2 Honours degree, or higher, in architecture and ARB/RIBA Part 1. An equivalent architectural degree to Part 1 may be acceptable, but applicants must be aware that they cannot progress to ARB/RIBA Part 3 without having completed and passed Parts 1 and 2 in order to register as an architect in the UK, according to current UK government legislation.

In order to be eligible to apply to register as an architect in the UK, you must have completed and passed ARB/RIBA Parts 1 and 2 programmes and have 'recently completed a minimum of 24 months' practical experience under the direct supervision of a professional working in the construction industry. Please note: your experience in practice during the LSA MArch in Designing Architecture (ARB/RIBA Part 2) programme that is undertaken as part of your educational course in the integrated placement for the modules Critical Practice: Placement and Critical Practice: Theory cannot be counted towards your 24 months' practical experience. Applicants are required to demonstrate talent as a designer as well as ability and motivation to complete the programme successfully. The school is looking for its students to rise to the ambitious challenge set by the programme. Students should be familiar with the strategic aims of the school with respect to social and civic responsibilities and the climate emergency.

Applicants will be expected to present a portfolio and demonstrate their ambition for the subject area and for studying at postgraduate level. Applicants need to be eligible to study in the UK for the full duration of the programme, and to be eligible to work in the UK for the duration of the work placement, subject to current UK legislation.

The LSA does not currently have a Student Route Visa (previously 'Tier 4') UKVI license. EU and International students, who are currently residing

in the UK and are already in possession of alternative visas, which do allow for study and work within the UK, are eligible to apply. However, it is the responsibility of the applicant to check with local UK immigration authorities regarding the above. Those doing so must make evidence of this explicit upon their application to the LSA by submitting their Home Office share code as part of their application.

English language requirements

Students whose first language is NOT English must provide evidence of their English language skills demonstrated by:

 the equivalent of level B2 of the Common European Framework of References for English language to study at degree level or above
 by gaining a further English language qualification if deemed achievable by the LSA

To meet the English language requirements of the LSA, candidates must obtain one of the following language qualifications:

- IELTS (UKVI): A score of 6.0 overall is required, with at least 5.5 in each category. IELTS reports have a two-year validity period. Certificates must therefore have been obtained within two years of the candidate's visa application date
- Trinity College SELT Test (ISE II (B2) or ISE III (C1)): A pass is required in each category at minimum. Trinity reports have a two-year validity period
- Pearson PTE (Academic UKVI): A score with at least 51 in each category

English language exams vary in terms of how long they remain valid. Candidates should provide the LSA's Admissions Team with a scanned copy of their official test certificate and the TRF number from that certificate. The required scores must be achieved during a single sitting of the examination.

In addition to the above, applicants may also choose from one of the following English language test and qualification options:

- GCSE/IGCSE English, IGCSE English (First Language) or English Language: Pass at 5 (or grade C) is required
- A Level English Language or English Language and Literature or English Literature: Grade C or above is required
- IB English A (SL) and IB English A (HL): Language and Literature or Literature: Grade 5 or above is required
- IB English B (for non-native speakers) (SL): Grade 7 or above is required
- IB English B (for non-native speakers) (HL): Grade 5 or above is required

Applicants must enter the name and result of their test on their application, and provide an original copy at registration. If an applicant doesn't have one of these qualifications but is currently being taught in English, they may contact the LSA's Admissions Team for advice at admissions@the-lsa.org.

Admissions process

- Step 1: Check that you meet all admissions requirements
- Step 2: Check all details below for the portfolio
- Step 3: Complete the two-stage application form (including contact details, personal information, a statement of purpose and portfolio alongside any required supporting documents) on the LSA website (https://the-lsa.org/admissions)

Upon receipt of a completed online application form, LSA staff will select applicants for interview, which will take place in London, but may be conducted by video call if the applicant is currently living abroad. Each interview panel will comprise at least one senior member of staff, a member of faculty and, where possible, a current student. Students selected for interview will be asked to complete a concise design exercise to bring to the interview.

The school will afford applicants the opportunity to present evidence of their qualifications, experience and commitment to the demands of the profession, including a portfolio presentation. The panel will assess aptitude for the course, with reference to four essential skills:

- Understanding/analysis
- Method/rigour of research
- Representation/communication
- Design skill

Conditional academic places will be offered to successful applicants in writing, and these will be only confirmed as unconditional once a practice placement position has been secured. Applicants will be asked to provide evidence of eligibility prior to registration.

Portfolio

A maximum 16-page edited portfolio to include:

- Undergraduate/BA architectural project work: show process and synthesis of design proposal(s) [12 pages]
- Evidence of work experience and any independent project work highlighting your specific contribution [4 pages]

Refer to the online application form for full details.

Statement of Purpose

The LSA asks for a Statement of Purpose instead of a Personal Statement. You will be asked to considerthefollowing subjectareas and complete them within the application form. Thebelow is for guidance only.

Motivation

What attracts you to the LSA?

What are your ambitions in undertaking this MArch in Designing Architecture, ARB/RIBA Part 2 programme?

What are your areas of interest within and outside of architecture, and how do you see the LSA being able to support them?

Design

Describe your design processes and methods. What kind of spatial thinker are you?

How do your preferred design tools help you to problem-solve? Describe your undergraduate thesis. Include comments on the brief, design approach, technical and contextual integration.

Practice

Outline 2 contributions you have made to projects in practice (these should correspond to your portfolio submission).

If you are invited to an interview, we will require an additional concise design exercise. We will provide you with the brief and all details in your invitation letter.

References

Both academic and employment references are required to be presented on official headed paper with original signature (not a jpeg signature) and must contain the referee's contact details.

For maturestudents who have been out of education formorethan three years, references should be from your employer or a professional (doctor, lawyer etc.) who can give you a personal reference.

If you receive an offer, we will ask you to contact your referees and submit your reference via email to admissions@the-lsa.org.

Academic transcripts / certificates

Academic transcripts and degree certificates must be supplied to account for ARB/RIBA Part 1 or equivalent years of degree studies. If you have not completed your studies, please include transcripts to date. If you have also completed postgraduate study, please upload these documents as well. Overseas applicants must supply transcripts and certificates that have been officially translated into English bearing the stamp and signature of the translator.

Interview outcome

Upon completion of the interview and assessment of the applicant's aptitude for the course, the applicant will receive one of the following responses in writing:

- Conditional Offer Letter to be confirmed once the applicant has secured a practice placement position.
- Waiting List Offer email to be confirmed once all applicant interviews have taken place throughout the admissions cycle. Please note this does not quarantee a place to study.
- Unsuccessful Application email unsuccessful applicants will be provided with some feedback in their outcome email.

The LSA aims to process applications in a timely way by ensuring that the application process is regularly reviewed with members of academic and administrative staff. The assessment of applicants will be transparent and the reasons for a decision will be recorded.

Accepting your place

To accept your offer of a conditional place on the taught programme please notify the school by the date specified on your offer letter.

You should indicate whether you are seeking a placement within the Practice Network, or through one of the other routes (as outlined in this handbook). At this stage you will need to provide a deposit of £500.

Please note that the deposit is non-refundable after a 14 day cooling-off period.

The London School of Architecture banks with HSBC and our deposits account number is 50024716 and sort code 40-11-60. As your reference, please use the initial of your first name and then full surname, e.g. the reference for Joan Smith would be JSMITH.

Once you have secured a suitable Student Placement, you will have met the conditions of your offer, and we will issue you with a firm offer letter. At this stage an additional £100 deposit is due for administrative costs. Again, please note the deposit is non-refundable after a 14 day cooling-off period.

All offers are subject to you providing original certificates of the qualifications upon which your offer has been based, prior to registration. If you do not have these documents you must bring certified replacements to your registration. Failure to provide this documentation or production of fraudulent qualifications will result in your offer being revoked.

Please note that:

Student Loan Company - deposits are repaid to students in May of First Year once the fees for that year have been paid in full by the SLC.

Self funded – deposits are deducted from the first terms invoice, for example, £3000 is due for the first term less £700 = £2,300 to pay. Terms 2 and 3 are charged at £3000/term.

Deferring an offer

Should an applicant wish to defer (one year only) entry to the programme for the current academic year, they may be able to request a deferral. All deferral requests must be sent to admissions@the-lsa.org. Please note that if you decide to defer, when you return to study you will be charged the tuition fees relevant to the year of re-entry.

Complaints and appeals

If an applicant wishes to submit a complaint* regarding the processing of their application or appeal** a decision, the applicant should contact admissions@the-lsa.org stating the nature of the complaint/appeal.

*A complaint would constitute a procedural error occurred during the admissions process.

**An appeal is defined as a requestforreconsideration of a reject decision. The LSA will not normally, after a reject decision, reverse the decision unless the candidate's performance demonstrates a significant improvement on the original assessment/interview. Applicants may be requested to do an additional piece of work to demonstrate required attributes that were under represented at the first interview.

Key dates

The application deadlines will be published on the LSA website. Applications received after the deadlines will be considered if there is availability on the course. Up to date information on open days and term dates will be published on the LSA website.

2 Practice placements

Placement process

A central component of the LSA's MArch in Designing Architecture is the relationship between academia and practice. The School maintains a Practice Network in London to support the programme. Each student must have completed 10 months in a Student Placement as part of their First Year. There are 3 routes to securing a Student Placement.

Route 1

Offer Holders who are employed by a London-based practice are encouraged to remain there if the practice declares its willingness for that employee to work part-time within the terms set out in the Student Placement Agreement.

Route 2

Offer Holders not employed by a London-based practice or seeking a new employer should independently and actively seek to secure their own placement with another London-based practice with immediate effect.

Offer Holders are encouraged to seek their placement through Route 2 allowing more freedom to find a practice themselves and to use Route 3 as their final option.

NOTE: Placement Providers are automatically validated as a Placement Provider if they are a RIBA chartered practice, however we can conduct a simple assessment and interview of non-RIBA Chartered Practices to ensure suitability for the programme. This involves a review of past projects and a short meeting.

Offer Holders may be directed to Route 3 by practices they contact.

Route 3

Some offer holders may require additional support from the LSA to secure a Student Placement. This may be for a range of reasons, typically that they Offer Holder is not currently based in London so struggling to get to interviews, or they have specific needs. In this instance, the LSA will undertake the formal matching process as follows:

Step 1: Matchmaking

We consider student's project and practice experience and engage with prospective Placement Providers to identify their needs and requirements.

Step 2: Interview

The LSA organise and manage the interview process to try to ensure that all offer holders receive placement offers.

Step 3: Placement Allocation

The LSA will conduct a mapping exercise to allocate placements using the information provided by Offer Holders and Placement Providers so that all Offer Holders in the process have a placement.

Step 4: Confirmation

The LSA inform both Offer Holders and Placement Providers of successful placements.

Through this process we do not envisage any Offer Holders to be without a Student Placement, however if this situation arises a second round of interviews will take place following the same matchmaking and interview process and the LSA will seek to identify further potential opportunities within the Practice Network.

We will do everything we can to support a Student Placement for Offer Holders, but we cannot guarantee this as ultimately the decision to offer a contract of employment resides with the Placement Provider.

Financial information

Tuition Fees

Home Fees 2025/26

For Home students registering for 2025/26 the tuition fees are £9,000 per year for both the First and Second Year.

Tuition fees are due and payable at registration for each year, and you have three payment options:

- 1. Self-Financing Students to pay in full. You are entitled to a five per cent discount if full payment of that year's fees is made prior to or at registration.
- By three instalments. The annual fee can be split evenly between the three terms, at the latest on 30 September 2025, 30 January 2026 and 30 April 2026.
- 3. Through Student Loan Company (SLC) application for tuition fee loan and/or maintenance loan (see further advice below).

You are required to ensure that you have secured funds to pay your tuition fees at the point of enrolment. Students who anticipate difficulty in making tuition fee payments as outlined above should contact the school as soon as possible to discuss their financial position and options.

- EU/EEA students who have been living in the UK for 3 years or more and have pre-settled or settled status: will be eligible for Home Fees of £9,000 and will be able to apply for the full amount from the SLC.
- International students who have lived in the UK for more than 3 years, have a visa (allowing you to live and study in the UK) for the duration of the course will be eligible for Home Fees of £9,000 but not be eligible for SLC funding.

If you are an international student we will send you a fee assessment to establish if you are eligible for Home Fees if you are offered a place.

Overseas Fees 2025/26

For students who are not eligible for Home Fees (for example, EU/EEA/international students who have been living in the UK for less than 3 years) tuition fees will be £15,000 – these students will not be eligible for SLC funding.

Additional Costs

Items such as laptops, accommodation and living costs are extra to tuition fees. You may also incur additional costs for: study trips, materials, photocopying, printing, library annual subscription/s, additional lecture admission fees, conference fees, specialist workshops if required.

Student Finance

Home Students at the LSA are eligible to apply for student finance tuition fee loans and for a maintenance loan.

The London School of Architecture's MArch Designing Architecture is Part 2 of your 5 year architectural education and as such is <u>eligible for Undergraduate</u> funding as together Part 1 and Part 2 are considered a single course as long as:

- You have not withdrawn from your Part 1 course before starting your Part 2
- You have studied full-time throughout your Part 1.
- You have not undertaken another MA programme before starting Part 2
- There has been no longer than 3 years between completing Part 1 and starting Part 2. (where the gap exceeds 3 years the SLC has discretion to assess whether a connection with architecture has been maintained)

You can apply for your undergraduate funding via the SLC.

If you are not eligible for UG funding, you may be eligible for the <u>postgraduate</u> <u>loan</u> that is £12,167 for 2025/26. This loan is paid directly to you and you can use it to pay for your tuition fees and/or living expenses.

Please note when making your application:

- Your university is The London School of Architecture
- The programme is the MArch in Designing Architecture
- You will be studying full time and in university (not on a placement year)
- The programme code for undergraduates loan is 896946
- The programme code for Northern Ireland is 906223
- The programme code for postgraduate loans is 96959
- Please make sure that you apply for funding as soon as you can so that you have arrangements in place for when you are due to start your studies in September.
- Ensure that you can manage all your study related costs and living expenses. Some useful information and budgeting tools can be found on these websites:

Bursaries & Scholarships

Bursaries and Hardship Funding

A per-annum bursary in the range of £1000 per year will be available to selected students.

The following processes are also in place:

If demand exceeds the number of bursaries available, students will be prioritised on your home postcode given in your application, AND a household income of under £16 000. (to enquire as to whether you meet the adult quintile postcode criteria, please contact admissions@the-lsa.org)

We may also decide to utilise available money from the Hardship Fund (seebelow) to award additional bursaries, where deemed necessary.

Should demand be less than the number of bursaries available, any unallocated bursary funds can be reallocated into the Hardship Fund (seebelow).

We will provide significant additional funding as part of our Hardship Fund, to which students can apply for support (whether or not they have received a bursary). Hardship Fund allocations will be made on an individual basis, based on demonstrated financial need. These funds can supplement bursary allocations or provide financial support to students who do not meet the bursarycriteria. Funds can be used to cover additional costs associated with an architecture course, such as model making and printing, to ensure successful participation in learning.

Students who have been allocated bursaries will be notified in Term 1 and fundswill be disbursed over Terms 1, 2 and 3.

School and student commitments

Attendance

The school will require students to be punctual and to attend where timetabled. The Programme Handbook identifies circumstances (such as certificated illness or bereavement) which the school will treat as exceptions; where this is the case efforts will be made to assist the student with access to make good missed learning opportunities.

A register of attendance will be recorded and analysed. Where necessary the school will draw the consequences of lateness or absence to the attention of a student. The Programme Handbook specifies circumstances in which a student who fails to comply with attendance requirements will be excluded from the programme. All students are expected to attend regularly throughout the academic year inclusive of the last day of the academic year.

Pastoral care

The Registrar and Programme Manager are responsible for the pastoral care of the students. Students are encouraged to make a judgement about the appropriate level for the help they need and will be made aware that the LSA welcomes them to connect with this network of support at any point of access. The LSA will make counselling available to its students as appropriate and is supported by its academic partner the University of Liverpool.

Academic Support

The Part 2 Programme Lead and Programme Manager are responsible for providing academic support and guidance. They also help to develop and maintain constructive and professional relationships with tutors and Practice Mentors.

Disabilities

The LSA is committed to supporting applicants with disabilities. In order to support applicants and their studies it is important that the LSA is made aware of any disabilities during the application stages and at interview. The relevant information must be indicated on the online application form. The LSA will put in place a Learning Support Plan and share with relevant Faculty.

Students with a disability or a long term health condition may apply for <u>Disabled Students' Allowance</u> at the same time as applying for SLC loans. Please ensure that you do this in good time so that your support is in place by the start of the academic year. This is external government support.

In addition, we work closely with the Access Team at the University of Liverpool and can refer you for an internal assessment to recommend reasonable adjustments for the learning and teaching on your programme.

Intellectual Property and Data Protection

All intellectual property rights created by you in connection with work on the Practice's projects belong to the Practice; all other intellectual property rights created by you in connection with work on the LSA's projects shall belong to you and the LSA jointly.

You agree that we can use work you have created on the course for any publication or publicity relating to the LSA.

You consent to:

- the LSA and the University of Liverpool processing your personal data for the purposes of administering the programme;
- your personal data being disclosed by the LSA and/or the University to the Higher Education Statistics Agency or equivalent body or to third parties (for example, progression information required by sponsors, references to potential employers, the Home Office and external bodies such as Edexcel and CGLI) where necessary. The LSA is GDPR compliant and adheres to the new Data Protection Act 2018 (DPA 2018).

Resources

You accept that you must provide your own computer and software for your course. This will not be provided by the LSA or the University of Liverpool. The LSA maintains A4, A3, A2 and A1 printing facilities and access to a network of associated fabrication workshops through our Practice Network.

Application Information

Upon submitting the application form candidates certify that the work submitted is entirely their own and the information provided is correct. If submitting collaborative work, specify this and clearly indicate your role and responsibility. Plagiarism is unacceptable in the academic setting. The LSA takes academic misconduct very seriously and seeks at all times to rigorously protect its academic standards. Any incorrect information or work submitted as part of an application may result in the withdrawal of an offer of a place.

Course award outcome

Upon the successful completion of your two-year programme, you will receive the Masters in Designing Architecture ARB/RIBA Part 2, awarded by the University of Liverpool. If you successfully complete the first year of your course but do not complete the second year, you may be entitled to a Graduate Certificate in Designing Architecture.
